## VILLAGE OF MURRAY, NEBRASKA January 9, 2024

The Murray, Nebraska Board of Trustees met in regular session on Tuesday, January 9, 2024, at 7:00 pm in the Murray Municipal Building. Present: Trustees: Jeff Anderson, George Blessing, Stan Flak, Zach Schroeder; Village Clerk Shelli Hayes, Maintenance Operators Jerome Speck and Ben Moore, Village Attorney Roger Johnson, and guests.

Notice of the meeting was given in advance thereof by posting in (3) three public places as shown by the certificate attached to these minutes and published in the Omaha World Herald on December 29, 2023. Notice of the meeting was simultaneously given to the Chairman and all members of the Board of Trustees. Their acknowledgement of receipt of notice and agenda is attached to these minutes. All proceedings thereafter were taken while the convened meeting was open to the attendance of the public.

requested by Josh Watson as agent for USCOC Nebraska/Kansas, LLC for locating a telecommunications tower with a tower tip height of 194.0 ft. AGL and an overall height of 1271.45 ft. AMSL on ground with an elevation of 1077.45 ft. GE, with related equipment at the base, at 606 Murray Road, Murray, Nebraska 68048, which is a part of Lot 19 in the SE 1/4 of the SW 1/4 of Section 13, Township 11, Range 13, Cass County, Nebraska. Following public comment, Chairman Anderson closed the hearing at 7:15 pm.

Motion by Blessing, seconded by Flak that the Board finds regarding the US Cellular Tower Special Use Permit Application, the use is compatible with and similar to the use permitted in the district, does not require re-zoning, is not detrimental to adjacent properties, does not tend to depreciate surrounding structure of property values, is compatible with the intended district uses; does not change the character of the district, and is in accordance with the Comprehensive Plan, and therefore approves the Special Use Permit Application for USCOC Nebraska/Kansas, LLC for locating a telecommunications tower at 606 Murray Road, Murray, Cass County, Nebraska; ayes: Blessing, Flak, Schroeder; nays: Anderson; motion carried.

Chairman Anderson introduced and read by title Ordinance # 683, second reading entitled: AN ORDINANCE TO ENACT ARTICLE 8, ACCESSORY USES AND SUPPLEMENT REGULATIONS, RELATED TO SOLAR REGULATIONS, CONSISTING OF SECTIONS 8.11.01 THROUGH SECTION 8.11.05 OF THE MURRAY, NEBRASKA, ZONING REGULATIONS 2004; TO REPEAL ALL ORDINANCES IN CONFLICT, EXPRESSLY INCLUDING SECTION 150.03 OF TITLE XV, LAND USE, CHAPTER 150 BUILDING REGULATIONS, OF THE MURRAY, NEBRASKA, CODE OF ORDINANCES; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND TO PROVIDE AN EFFECTIVE DATE.

Chairman Anderson introduced and read by title Ordinance # 684: AN ORDINANCE TO AMEND TITLE III, CHAPTER 30, SECTION 30.25, ENTITLED READING AND PASSAGE OF ORDINANCES, RESOLUTIONS, ORDERS AND BYLAWS; TITLE III, CHAPTER 34, SECTION 34.63, ENTITLED PROPERTY TAX REQUEST; PROCEDURE FOR SETTING; AND TITLE III, CHAPTER 34, SECTION 34.64 ENTITLED PROPERTY TAX REQUEST; INCREASE BY MORE THAN ALLOWABLE GROWTH PERCENTAGE; PROCEDURE FOR SETTING; TO ENACT TITLE VII, CHAPTER 70, SECTION 70.03 ENTITLED TRAFFIC REGULATIONS; GENERAL AUTHORITY; TO REPEAL ALL ORDINANCES IN CONFLICT; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND TO PROVIDE AN EFFECTIVE DATE.
