Chairman Anderson introduced and read by title Ordinance # 691: AN ORDINANCE OF THE VILLAGE OF MURRAY, NEBRASKA, TO PROVIDE FOR AN INCREASED SEWER RATE FOR THE USE OF THE VILLAGE OF MURRAY'S SEWAGE SYSTEM FOR ALL CLASSES OF CUSTOMERS, AS CODIFIED IN VILLAGE OF MURRAY, NEBRASKA CODE OF ORDINANCES, TITLE 52 "SEWERS", SECTION 52.15 "RATE SETTING"; TO REPEAL ALL ORDINANCES OR

RESOLUTIONS IN CONFLICT; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND TO PROVIDE AN EFFECTIVE DATE.

Motion by Schroeder, seconded by Blessing to approve Ordinance # 691 on first reading by title only and suspend the three (3) required statutory readings; ayes: Blessing, Flak Schroeder, Anderson; motion carried.

Motion by Blessing, seconded by Schroeder to adopt on third and final reading by title only, post, and publish Ordinance # 691; ayes: Blessing, Flak, Schroeder, Anderson; motion carried.

Chairman Anderson made recommendation for Lea Bartlett to fill the vacancy on the Board of Trustees. Motion by Anderson, seconded by Blessing to appoint Lea Bartlett to serve the rest of the vacant term until December 2028; ayes: Blessing, Flak, Schroeder, Anderson; motion carried. Clerk Hayes administered the Oath of Office to Ms. Bartlett.
