The Murray, Nebraska Board of Trustees met in regular session on Wednesday, May 15, 2024, at 7:00 pm in the Murray Municipal Building. Present: Trustees: Jeff Anderson, George Blessing, Stan Flak, Zach Schroeder, Rowdy Woodard; Village Clerk Shelli Hayes, Village Attorney Roger Johnson, and guests.
