

ORDINANCE NO. 680

AN ORDINANCE OF THE VILLAGE OF MURRAY, NEBRASKA, TO CONSTRUCT A MUNICIPAL BUILDING TO USE PRIMARILY AS A MAINTENANCE SHOP; TO REPEAL ALL ORDINANCES IN CONFLICT; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND TO PROVIDE AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF MURRAY, NEBRASKA:

Section 1. A resolution was previously adopted to consider the construction of a municipal building to use primarily as a maintenance shop.

Section 2. Notice of the proposed construction was published in the Omaha World-Herald on August 11, 2023 which is a legal newspaper of general circulation in the village.

Section 3. The notice advised the public of the right so seek and file with the Village a remonstrance petition in opposition to the construction.

Section 4. No remonstrance petition was filed with the Village within 30 days after publication of the notice.

Section 5. The Chair of the Board of Trustees of the Village of Murray, Nebraska is hereby authorized to execute contracts with the construction companies whose bids were accepted by the Board.

Section 6. All ordinances passed and approved prior to the passage and approval of this ordinance which are in conflict are repealed.

Section 7. This ordinance is hereby adopted and ordered published in pamphlet form.

Section 8. This ordinance shall take effect, and be in full force, from and after its passage, approval, and publication or posting as required by law.


