#### ORDINANCE NO. 689

AN ORDINANCE OF THE VILLAGE OF MURRAY, NEBRASKA TO ESTABLISH WAGES AND BENEFITS FOR VILLAGE EMPLOYEES EFFECTIVE OCTOBER 1, 2024; TO REPEAL ALL ORDINANCES IN CONFLICT; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND TO PROVIDE AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF MURRAY, CASS COUNTY, NEBRASKA:

**Section 1.** Effective October 1, 2024, wages and benefits for village employees and appointed officials shall be:

#### WAGES

Clerk/Treasurer	\$23.50/hour
Full-time Maintenance	\$24.41/hour
Seasonal Maintenance	\$20.00/hour
Part-time Maintenance	\$20.00/hour

Village Board Chair \$225.00/per calendar quarter Village Trustee \$150.00/per calendar quarter

#### **INSURANCE**

The Village will pay \$500.00 per month toward the premium for health insurance coverage for full time employees and their dependents.

### PERSONAL CELL PHONE USAGE

The Village will pay \$35.00 per month as reimbursement for the employees' use of personal cell phones for Village business.

### OTHER PAID LEAVE (Covered in Employee Handbook)

Military; Civil

#### HOLIDAYS

Employees shall be paid for the following holidays:

New Year's Day; Martin Luther King Jr. Day; Presidents' Day; Memorial Day; Independence Day; Labor Day; Columbus Day; Veterans Day; Thanksgiving and the day following; Christmas Day.

#### VACATION (Covered in Employee Handbook)

Vacation time shall accrue as follows:

After one (1) year of work = One (1) week paid vacation

After three (3) years of work = Two (2) weeks paid vacation

After eight (8) years of work = Three (3) weeks paid vacation

After fifteen (15) years of work = Four (4) weeks paid vacation

After twenty (20) years of work = Five (5) weeks paid vacation

- **Section 3.** All other ordinances passed and approved prior to the passage, approval, and publication or posting of this ordinance and in conflict with its provisions are repealed.
- **Section 4.** This ordinance is adopted and published in pamphlet form and shall take effect and be in full force from and after its passage, approval, and publication or posting as required by law.
