

ORDINANCE NO. 705

AN ORDINANCE OF THE VILLAGE OF MURRAY, NEBRASKA TO ACCEPT THE DEDICATIONS OF STREETS AND UTILITY EASEMENTS FOR THE BENEFIT OF THE PUBLIC AS SET FORTH ON THE "FINAL PLAT" OF SUNRISE VILLAGE REPLAT, AN ADDITION TO THE VILLAGE OF MURRAY, CASS COUNTY, NEBRASKA, AN ADMINISTRATIVE SUBDIVISION, OF LOTS 1A THROUGH 8B, (INCLUSIVE), SUNRISE VILLAGE, LOCATED IN THE W1/2 OF THE SE1/4 OF SECTION 15-T11N-R13E OF THE 6TH P.M., VILLAGE OF MURRAY, CASS COUNTY, NEBRASKA; TO REPEAL ALL ORDINANCES IN CONFLICT; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND TO PROVIDE AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF MURRAY, NEBRASKA:

1. A "Final Plat" of Sunrise Village Replat, an Addition to the Village of Murray, Cass County, Nebraska, an administrative subdivision, of Lots 1a through 8b, (inclusive), Sunrise Village, located in the W1/2 of the SE1/4 of section 15-T11N-R13E of the 6TH P.M., Village of Murray, Cass County, Nebraska which contained a dedication streets and utility easements to, and for the benefit of, the public.

2. The dedication of streets and utility easements are hereby accepted.

3. If this Ordinance becomes effective as set forth below, all other ordinances approved prior hereto are repealed.

4. This ordinance is adopted and published in pamphlet form and shall take effect and be in full force from and after the recording of the "Final Plat" of Sunrise Village Replat in the office of the Register of Deeds, Cass County, Nebraska and its publication as required by law.

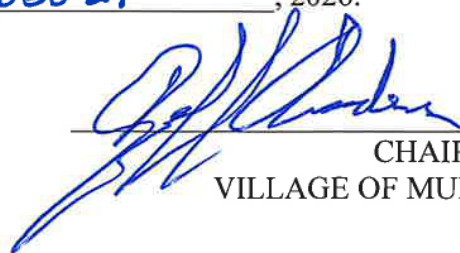
