The Murray, Nebraska Board of Trustees met for the purpose of holding a public hearing for the One and Six Year Road and Street Plan on Tuesday, September 9, 2025, at 7:00 pm in the Murray Municipal Building. Present: Trustees: Jeff Anderson, George Blessing, Stan Flak, Zach Schroeder, Lea Bartlett; Village Clerk Shelli Hayes, Maintenance Operator Jerome Speck, Village Attorney Roger Johnson; and guests.

Notice of the meeting was given in advance thereof by posting in (3) three public places on August 27, 2025, as shown by the certificate attached to these minutes, and published in the Omaha World Herald Notice Section on August 27, 2025. Notice of the meeting was simultaneously given to the Chairman and all members of the Board of Trustees. Their acknowledgement of receipt of notice and agenda is attached to these minutes. All proceedings thereafter were taken while the convened meeting was open to the attendance of the public.

Motion by Flak, seconded by Schroeder to adopt Resolution 25-03, One and Six Year Road and Street Plan 2025/2026 through 2030/2031; ayes: Blessing, Flak, Schroeder, Bartlett, Anderson; motion carried.

Motion by Bartlett, seconded by Schroeder to adopt Resolution 25-04, Municipal Annual Certification of Program Compliance to Nebraska Board of Public Roads Classifications and Standards 2025; ayes: Blessing, Flak, Schroeder, Bartlett, Anderson; motion carried.

With no further business, Chairman Anderson adjourned the meeting at 7:07 pm.
